#### 1. HEALTH AND SAFETY 101

In this workshop you will examine a variety of workplace hazards, recognize the laws and/or regulations that apply to these hazards and identify the importance of local safety and health committees. # 2. CHEMICAL HAZARD RECOGNITION, STORAGE AND DISPOSAL FOR COLLEGES AND UNIVERSITIES

Colleges and universities house large amounts of hazardous chemicals: in science departments, research centers, facilities maintenance and art departments. This session will touch on how chemicals should be managed; what EPA and OSHA look for and what local unions should be asking campus administrators to protect the health and safety of employees. This session would also be useful to high school science and art instructors and custodial and maintenance personnel.

#### 3. WORKPLACE VIOLENCE

#### 4. UNDERSTANDING STUDENT DISABILITIES

You will acquire a general understanding of the 13 disability categories and key concepts related to the education of students with disabilities. In addition, you will experience what it is like to have a disability and learn strategies for improving student learning and behavior. This session will also provide strategies that can be used to support students with autism. Topics include: characteristics of autism and Asperger's Syndrome; specific techniques for normalizing environments; reducing disruptive behavior, and enhancing language and social skills.
