## APRIL 2026 ALL URBAN CONSUMERS

The United States City Average Consumer Price Index (CPI-U) for **April 2026** was **333.020**— representing a change of **3.8** percent over the index for **April 2025**.

The Northeast Area Consumer Price Index for **April 2026** was **347.585**— representing a change of **4.4** percent over the index for **April 2025**.

The New York-Northern New Jersey Area Consumer Price Index for **April 2026** was **359.774**— representing a change of **4.6** percent over the index for **April 2025**.

The **May CPI** will be available **June 10, 2026**.

Future projections of the CPI by businesses and economic organizations are found on page 3. CPI increases are projected **3.4** percent for **2026** and **2.5** percent for **2027**.

A large number of organizations project increases in the Consumer Price Index. NYSUT subscribes to *Blue Chip Economic Indicators*. This monthly publication presents 2026 and 2027 economic projections from approximately 50 sources.

### *Projected Increases in the Consumer Price Index U.S. City Average All Urban Consumers*

*Blue Chip Economic Indicators*, published by Aspen Publishers, Inc. This forecast uses the projections from approximately 50 different organizations, and the consensus of these projections is reported here.

*Blue Chip* also reports that 28 of the 45 forecasters contributing to its **2026** consensus CPI projection were revised upward from the prior month. Eleven were unchanged and 6 were revised downward. Eighteen of the 44 forecasts for **2027** were unchanged, 18 were revised upward and 8 were revised downward.
