JOB SECURITY AND MEMBER RIGHTS

Prohibition on Unilateral Diminution of Retirees' Health Insurance – All Public Employees

S-3627	Lanza	Civil Service & Pensions Committee
A-902	Weprin	Governmental Employees Committee

Prohibits a public employer from diminishing the health insurance benefits provided to retirees and their dependents or reducing the contributions, which the public employer makes toward these benefits, unless also making an equivalent change for active employees.

Right of Action for School Employees

Legislation Pending Introduction

Provides any employee of a school district or board of cooperative educational services, or his/her survivors, a statutory right of action in a case of any caused injury, death, willful or culpable negligence on the part of any person or governmental entity in failing to comply with governmental requirements.

Seniority Protection for Physical and Occupational Therapists During Program Takeovers

Legislation Pending Introduction

Includes physical and occupational therapists in current provisions regarding protection of tenure and other rights when a BOCES takes over a program formerly provided by a school district or vice versa.

Teacher Transfers - Salary Protection

Legislation Pending Introduction

Provides that employees transferred to another school district pursuant to Section 3014 a-d of the Education Law shall maintain their current salaries and such salaries shall not be reduced.

Domestic Partner Benefits

- S- Legislation Pending Introduction
- A-3901 Glick Labor Committee

Allows employees to utilize sick leave to care for family, household members and domestic partners.

S-2110-A	Montgomery	Investigations and Government Operations Committee
A-3948-A	Glick	On Third Reading

Allow individuals whose domestic partners are receiving, employer-provided such as health insurance benefits, to deduct the cost of that benefit from their taxable income for state tax purposes.

S-215	Squadron	Crime Victims, Crime and Correction Committee
A-4024	Glick	On Third Reading

Allows domestic partners of homicide victims to be eligible for compensation from the Crime Victims Board for actual out of pocket losses and counseling expenses.

Due Process for Civil Service Employees

Legislation Pending Introduction

Requires that cases brought against civil service employees pursuant to Section 75 of the Civil Service Law shall be held by a hearing officer selected by the mutual agreement of the person against who charges are being brought and the employer. In addition, this bill protects civil service employees from being suspended without pay pending a determination of the charges.

Charter Schools – Anti-Union Bias

Legislation Pending Introduction

Prohibits the conversion of an existing public school to a charter school in cases where determined that the school demonstrates or has demonstrated a practice of anti-union bias. The bill would allow public schools to apply for a conversion to a charter school at another time.

Paid Family Leave

S- Legislation Pending IntroductionA-3901 Glick Labor Committee

Provides up to 12 weeks of family-leave at full pay for public employees employed by an employer that has 50 or more employees.

Layoff Credit for Occupational and Physical Therapists

S- Legislation Pending Introduction

Counts time as a provisional towards layoff credit for all occupational and physical therapists hired prior to December 31, 2013.

TAYLOR LAW AND COLLECTIVE BARGAINING

Mitigating Circumstances

Legislation Pending Introduction

Provides that an impartial arbitrator may reduce the two-for-one strike penalty to an amount no greater than one and one-half days nor less than one day if the arbitrator finds that the strike was provoked.

Repeal Two-for-One

Legislation Pending Introduction

Amends the Taylor Law to repeal the two-for-one strike penalty against teachers and other public employees accused of striking.

Right to Strike

Legislation Pending Introduction

Amends the Taylor Law to reaffirm a public employee's inalienable right to withhold services.

Impasse Resolution

Legislation Pending Introduction

Amends the Taylor Law to provide if no agreement is reached within 180 days of the expiration of a contract, a declaration of impasse will be automatic and an expedited impasse proceeding will begin immediately. Amends the Taylor Law to give PERB the authority to levy escalating fines on either party trying to delay the process to ensure that both sides take negotiations seriously.

Employer Penalties and Mitigation

Legislation Pending Introduction

Provides employee organizations filing improper employer practice charge of failure to negotiate in good faith with a right to an expedited determination by PERB.

Employer Penalties

Legislation Pending Introduction

Amends the Taylor Law to provide that if an employer has been found by PERB to have engaged in an improper employer practice by refusing to negotiate in good faith, then the last offer of the duly recognized or certified representative of its public employees shall become the agreement between the employer and such employee bargaining unit until changed or modified by mutual agreement of the parties.

Claims Against School Districts

Legislation Pending Introduction

Amends the Education Law to remove the requirement for the filing of a notice of claim against school districts in matters that arise out of, or are the product of, matters within the purview of the Taylor Law.

Workplace Violence Reduction for SD's

S-1936	Addabbo	Labor Committee
A-6902	Heastie	Labor Committee

Relates to developing and implementing programs to prevent workplace violence in public schools.

Temporary Restraining Orders

Legislation Pending Introduction

Amends the Taylor Law to clarify that public employer/employee labor disputes can only be restrained under Taylor Law provisions.

The following bills were developed pursuant to the AFL-CIO Taylor Law Task Force (Legislation to Be Introduced by the AFL-CIO):

Employer Penalties and Mitigation

Legislation Pending Introduction

Provides employee organizations filing improper employer practice charge of failure to negotiate in good faith with a right to an expedited determination by PERB.

PERB Board Appointees

Legislation Pending Introduction

Provides that members selected to serve on PERB shall have served in a neutral capacity for not less than three years prior to appointment to the board.

Remedies for Strike Violations

Legislation Pending Introduction

Provides that the prohibition against strike activity and the imposition of penalties for violations of the prohibition are properly and exclusively labor relations matters to be addressed by the public employer of the employees involved and PERB, not by outsiders to the process.

Punitive Damages

Legislation Pending Introduction

Allows the Public Employment Relations Board to assess punitive damages upon a finding that a party has committed repeated improper practices or an egregious practice.

Contract Deferral/Lack of Jurisdiction

Legislation Pending Introduction

Grants the Public Employment Relations Board jurisdiction over certain alleged violations of an agreement between an employer and an employee organization.

EDUCATIONAL STANDARDS AND SERVICES

Truth in Testing for the Common Core

S-6009	Flanagan	Third Reading
A-8356	Nolan	Education Committee

The purpose of this bill is to ensure that new common core mandated state assessments are fair, unbiased, grade level appropriate and administered properly.

Truth About Testing Act of 2013

S-4712-A	Latimer	Education Committee
A-6594-A	Nolan	Education Committee

Requires a study and report on the total cost of student assessments; survey of teachers and administrators on test-prep time for student assessments; prohibits the use of certain assessments to be used for anything other than diagnostic purposes.

Unnecessary Testing in P-2 Grades - Chapter 56 of the Laws of 2014

S-6008	Flanagan	Enacted as part of 2014-15 State Budget
A-8355	Nolan	Enacted as part of 2014-15 State Budget

Prohibits administering standardized tests to students in prekindergarten through grade two, unless it is used for a diagnostic purpose or required by federal law.

Unnecessary Testing K-2 Grades

S-4764-B	Gipson	Education Committee
A-6593-A	Nolan	On Third Reading

Relates to standardized testing for grades kindergarten through grade two; prohibits the use of assessments for anything other than diagnostic purposes.

Common Core Reform - partially enacted in Chapter 56 of the Laws of 2014

S-

A-8929 Nolan Passed, specific sections enacted as part of 2014-15 State Budget

This legislation addresses concerns regarding the implementation of the common core learning standards, the effect of the common core aligned assessments on teachers, principals and students, as well as protection of student data and information.

Moratorium on High-Stakes Consequences – partially enacted in Chapter 56 of the Laws of 2014

S-

A-8929 Nolan Passed, specific sections enacted as part of 2014-15 State Budget

Requires a two-year moratorium on the use of high-stakes testing data for student and teacher accountability purposes, among other common core changes.

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

Mandates that no school district can place or include on a student's official transcript or maintain in a student's permanent record any individual student score on a state administered standardized ELA/Math assessment for grades 3-8 and cannot make any student promotion or placement decisions based solely or primarily on student performance on the state administered standardized ELA/Math assessments for grades 3-8. Requires notification of the district's grade promotion and placement policy.

Expedited Review of Material Changes - Chapter 56 of the Laws of 2014

S-6006	Flanagan	Enacted as part of 2014-15 State Budget
A-8354	Nolan	Enacted as part of 2014-15 State Budget

Requires expedited and limited review of material changes to Annual Professional Performance Review plans when changes will reduce testing.

Elimination of Tests - Chapter 56 of the Laws of 2014

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

Mandates the commissioner to reduce field tests for students and to make available more test questions for teachers and parents for 3-8 ELA/Math exams. Requires the commissioner to ensure teachers promptly receive information back on assessments in a form that encourages instructional feedback and improvement.

Common Core Resources - Chapter 56 of the Laws of 2014

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

Mandates the commissioner provide instructional tools and outreach materials for parents and families to assist in understanding the purposes, elements and instructional changes relating to implementation of Common Core Learning Standards. Requires the commissioner to develop professional development tools, resources and materials, including age-appropriate instruction that provide best practices for the effective implementation of the Common Core Learning Standards.

Reduction of Tests - Chapter 56 of the Laws of 2014

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

The commissioner must issues guidance to school districts in order to assist school districts to reduce and eliminate traditional standardized tests that are not required under state or federal law and prepare, for each school district, a testing transparency report listing all standardized assessments administered to students within the school district for which the department has record, by July 1, 2014.

Testing Time Audit – Chapter 56 of the Laws of 2014

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

Mandates that the amount of time devoted to state-administered required assessments or for standardized assessment not required under state or federal law, for each grade, does not exceed one percent of the minimum required annual instructional hours. Requires that the amount of time devoted to test preparation under standardized testing conditions for each grade does not exceed two percent of the minimum required annual instructional hours for such grade.

Testing for English Language Learners and Students with Disabilities – Chapter 56 of the Laws of 2014

S-6356-D	Budget Bill	Enacted as part of 2014-15 State Budget
A-8556-D	Budget Bill	Enacted as part of 2014-15 State Budget

Mandates regulations allowing students with disabilities who are not eligible for the New York State alternate assessment and whose cognitive and intellectual disabilities preclude their meaningful participation in chronological grade level instruction to be assessed on instructional level. Requires English language learners to be assessed with a state-administered assessments that measures the English language development of such students rather than the English language arts exam for their first two years of enrollment.

Student Data Privacy – Chapter 56 of the Laws of 2014

A-8353	Nolan	Enacted as part of 2014-15 State Budget

Prohibits the release of personally identifiable student information and establishes penalties for the unauthorized release of personally identifiable information.

S-4284	Grisanti	Education Committee
S-5932-A	Robach	Education Committee
A-6059-A	O'Donnell	Third Reading

Prohibits the release of personally identifiable student information where parental consent is not provided.

Parental Involvement Leave Act

S-1834	Parker	Labor Committee
A-284	Kim	Labor Committee

Enacts the Parental Involvement Leave Act requiring employers to grant employees up to 16 hours leave to attend school conferences or classroom activities.

Mandatory Suspension/Plan of Intervention

Legislation Pending Introduction

Mandates that a minimum suspension period be set for disruptive students who have been removed from the classroom by a teacher at least three times during the school year. The bill would also mandate that each school district's Code of Conduct contain a provision that requires the principal, in conjunction with parents, teachers and others, to develop and implement a Plan of Intervention that would address in a comprehensive manner the underlying causes of the student's disruptive behavior.

Training of School Board Members

S- Legislation Pending Introduction

A-4133	Englebright	Education Committee

Requires every trustee or voting member of a board of education of a school district or a board of cooperative educational services (BOCES) elected or appointed to complete training on the financial oversight, accountability, fiduciary and other responsibilities of a school board member.

Guidance Counselor Services

S- Legislation Pending Introduction

A-2981 Ortiz Education Committee

Requires that at least one full-time certified or licensed school guidance counselor is employed in each elementary, intermediate, middle, junior high and senior high school in the state. Such counselor is to be exclusive of any school guidance counselors funded or mandated through any special education funding, aid, regulation or statute.

Attendance Teachers, School Social Workers and School Psychologists

Legislation Pending Introduction

Requires that all school districts provide the services of attendance teachers, school social workers and school psychologists as prescribed by the Commissioner of Education and further requires that only duly certified attendance teachers, school social workers and school psychologists be employed to implement these services.

Library Media Specialists

Legislation Pending Introduction

Requires all school districts to maintain a school library in each elementary school building and to employ a certified school library media specialist or licensed teacher of library for each such school library.

School Bus Monitors

Legislation Pending Introduction

Requires committees of special education to consider school bus attendants, among services offered in a students Individualized Education Program (IEP).

Cleaner Fuels School Bus Act

Legislation Pending Introduction

Enacts the "cleaner fuels school bus act" requiring school bus owners to replace or retrofit buses to use biodiesel fuel blends.

BOCES Teaching Assistant and Teacher Aide Vacancies

Legislation Pending Introduction

Requires school district and BOCES to fill teaching assistant and teacher aide vacancies in a timely manner.

Outside Play Areas

Legislation Pending Introduction

Authorizes the Commissioner of Education to require school districts to adopt student/adult ratios governing the number of students to adults in attendance in outside play areas.

School Bus Driver Biennial Testing

Legislation Pending Introduction

Requires the Commissioner of Education to allow successfully completed State mandated biennial bus driver tests to be portable between school districts.

Languages Other than English

Legislation Pending Introduction

Requires review and evaluation of standards for languages other than English and establishes a pilot program to support regent's review of learning standards

Shared Decision Making-Parent Participation

Legislation Pending Introduction

Requires employers to release from work employees for service on school district committees during work hours without loss of pay, benefits or status.

Age-Appropriate Sex Education Grant Program

S-957	Parker	Health Committee
S-5897	Rivera	Health Committee
A-2694	Gottfried	Health Committee

This legislation amends the public health law to establish the Age-Appropriate Sex Education Grant Program or the Healthy Teens Act. The bill establishes a competitive grant program giving public school districts, BOCES, school based health centers and community based organizations the opportunity to provide at-risk adolescents with an age-appropriate sex education.

Promoting Instruction in Foreign Language

A-1973	Rozic	Education Committee

This legislation amends the education law to direct the commissioner of education to establish an incentive program for school districts wishing to implement programs of foreign language in the elementary schools. In addition, this bill establishes an incentive program for college students wishing to become foreign language teachers.

School Nutrition

S- Legislation Pending Introduction

A-3151 O'Donnell Education Committee

Provides for the development and implementation of statewide school nutrition standards, for the review of school wellness policies.

Teacher Loan Forgiveness Program

S- Legislation Pending Introduction

A-2993 Clark Higher Education Committee

Creates City University of New York center for excellence in urban education to enhance the quality of teaching in public schools in NYC; establishes the regents teachers loan forgiveness program to allocate awards annually to teachers who agree to teach public school in an area of New York state designated by the board of regents as having a shortage of public school teachers.

Teacher Loan Program – Shortage Areas

Legislation Pending Introduction

Establishes loan program to encourage undergraduates to enter teaching field in academic areas of critical teacher shortage in New York state; provides for selection of candidates based on academic study in critical areas as determined by the regents; sets duration of loan and amounts available.

Bilingual Teachers of Tomorrow

Establishes the bilingual teachers of tomorrow teacher recruitment and retention program to attract and retain bilingual, certified teachers in areas of greatest need, especially schools under registration review; provides for grants and procedures for applying for such grants and eligibility requirements for fund distribution.

Special Act Schools, 853 schools 4410 Programs

A -		Legislation Pending Introduction

Provides certain special education schools (853s, Special Act Schools and 4410 programs) with increased rates from the Department of Budget and to provide an alternative to Revenue Anticipation Notes (RANs) for Special Act school districts, 853 schools and 4410 preschool special education programs. Increases rates for special act school districts, 853 schools and 4410 preschool special education programs by establishing tuition rates that are equal to the personal income growth index used to calculate the school aid growth cap; also sets a 120 day window for approval of reconciliation rates for special act school districts, 853 schools and 4410 preschool special act school districts, 853 schools and 4410 preschool special act school districts, 853 schools and 4410 preschool special act school districts, 853 schools and 4410 preschool special act school districts, 853 schools and 4410 preschool special act school districts, 853 schools and 4410 preschool special education programs; establishes a revolving loan fund for special act school districts, 853 schools and 4410 preschool special education programs.

Revolving Loan Fund - Special Act School Districts

Establishes the special education short-term revolving loan fund authorizes the State Comptroller to provide special education short-term revolving loans to certain special act school districts or approved special education providers.

Variance in Class Size for Special Act School Districts

Legislation Pending Introduction

Includes special act school districts as an entity to obtain prior approval from the state education department for variance in class size.

Chartering Fairness – Charter School Reform

Relates to charter schools; clarifies the transparency and accountability of charter schools and provides fiscal relief Education Law.

Charter School Students Suspension Process

Provides charter school students have the same due process rights in regard to suspension as public school students.

Tuition and Reconciliation Rates for Special Education Schools and Providers

Provides certain special education schools (853s, Special Act Schools and 4410 programs) with increased rates from the Department of Budget and to provide an alternative to Revenue Anticipation Notes (RANs) for Special Act school districts, 853 schools and 4410 preschool special education programs.

PENSION & RETIREMENT

Pension & Retirement

This legislative session, NYSUT's legislative efforts have been intensely focused on defending our members' pensions from various attacks including the recent enactment of an additional reduced benefit pension tier. We will pursue post budget changes to the most problematic provisions of the Tier 6 legislation. The recently enacted Tier 6 legislation contains a provision that requires the state to pre-fund any pension benefit enhancement going forward. This new provision of law must now be considered when any organization seeks to advance legislation that will enhance retirement benefits for public employees.

The following bills apply only to members in the New York State Teachers' Retirement System:

Credit for Unused Sick Leave

Legislation Pending Introduction

Permits members of the New York State Teachers' Retirement System to receive service credit up to ninety days of unused accumulated sick leave.

Interest Payment for Delayed Retirement Allowance

Legislation Pending Introduction

Provides for the payment of interest on benefits due and owing to members of the New York State Teachers' Retirement System beginning with the 31st day after a member's effective date of retirement.

Repeal 75% Retirement Benefit Cap (Tiers I and II)

Legislation Pending Introduction

Repeals the retirement benefit cap of 75% of final average salary for Tier I and II members.

Registered School Nurses – NYSTRS Membership

Legislation Pending Introduction

Provides the opportunity for Registered Professional Nurses that work in school districts to join the New York State Teachers Retirement System.

The following bills apply to both the New York State Teachers' Retirement System and the New York City Teachers' Retirement System:

Minimum Guaranteed Pension

S- Legislation Pending Introduction

A-4924	Colton	Governmental Employees Committee
--------	--------	----------------------------------

Establishes a minimum guaranteed pension for teachers retired from the New York State Teachers' Retirement System or the New York City Teachers' Retirement System of \$500 times the number of years of credited service (e.g., with 20 years of service, the minimum guarantee would be \$10,000 per year).

Out-of-State Teaching Service

Legislation Pending Introduction

Permits members of the New York State Teachers' Retirement System and the New York City Teachers' Retirement System to claim retirement credit for out-of-state public school teaching service regardless of when such service was rendered.

Federal Service Credit

Legislation Pending Introduction

Permits members of the New York State Teachers' Retirement System and the New York City Teachers' Retirement System to claim retirement credit for Head Start, Peace Corps, VISTA or federal teaching service.

Job Corps Training Program

Legislation Pending Introduction

Permits members of the New York State Teachers' Retirement System and the New York City Teachers' Retirement System to claim retirement credit for service rendered with the New York State Job Corps Training Program.

Prior Out-of-State Service - (Tiers II, III and IV)

Legislation Pending Introduction

Permits Tier II, III and IV members of the New York State Teachers' Retirement System and the New York City Teachers' Retirement System to claim credit for prior out-of-state teaching service under the same conditions that currently apply to members of Tier I.

Retirees Returning to the Classroom

Legislation Pending Introduction

Authorizes retirees to return to full-time employment as teachers while keeping full pension benefits, provided, however, such retired members are returning to such employment at hard-to-staff schools and in teacher shortage areas.

Credit for Special Education Teachers

Legislation Pending Introduction

Allows members of the New York State Teachers' Retirement System and the New York City Teachers' Retirement System to claim retirement credit for service rendered with the Association of Retarded Citizens.

Tier IV Disability Requirement

Legislation Pending Introduction

For the purpose of disability retirement for Tier IV members of a Teachers' Retirement System, "disability" shall be defined as being disabled from further teaching service.

Beneficiary Retirement Payments

Legislation Pending Introduction

Eliminates the requirement that a beneficiary of a deceased member repay any retirement benefits received in the month of the member's death.

Teacher Retention

Legislation Pending Introduction

Eliminates the reduction of pension benefits calculated after 30 years of service by providing a pension factor of 2% per year for each year of service credited after 30 years.

Layoff Service Credit Buyback

Legislation Pending Introduction

Allows members of the New York State Teachers' Retirement and the New York City Teachers' Retirement System to purchase retirement service credit for the period during which they were laid off.

Retirement Allowance – Month of Death

Legislation Pending Introduction

Deems it unnecessary for the beneficiaries of a deceased retired member to repay any portion of the members' monthly retirement payment in the month of the retired members' death.

STAR Exemption – Retirement Income

Legislation Pending Introduction

Includes pension and retirement plans as plans eligible for income reduction when determining eligibility for enhanced STAR exemption.

Pop-Up Option/Divorce

S-5162-B	Savino	Civil Service & Pension Committee
A-6759-B	Abbate	Governmental Employees Committee

Allows a change in retirement options for certain retired members with the consent of the nominated survivor beneficiary.

The following bills apply <u>only</u> to the New York City Teachers' Retirement System:

Paraprofessional Entry into the Retirement System

Legislation Pending Introduction

This legislation mandates that paraprofessionals join the New York City Teachers' Retirement System as soon as they are eligible to do so. This bill would insure that upon retirement, paraprofessionals receive the maximum retirement benefit possible.

Retirement System Membership for BOE Employees in UFT Bargaining Unit

Legislation Pending Introduction

Permits persons holding regular substitutes and per diem certificates and certain other titles to join NYCTRS.

World Trade Center Presumption

Legislation Pending Introduction

Extends World Trade Center disability presumption and death benefit provisions to Tier I and II members of the New York City teachers' retirement system.

Paraprofessionals Tier Reinstatement

Legislation Pending Introduction

Provides tier improvement benefits to certain NYC paraprofessionals who were incorrectly informed by their employer that they were ineligible to join a public retirement plan upon initiating public employment.

Continued Health Coverage for Survivors

Legislation Pending Introduction

Allows spouses and partners of deceased members to continue to purchase City health insurance at their own expense.

Pension Credit for Workers' Compensation

Legislation Pending Introduction

Provides pension credit for the time a member spends on Workers' Compensation leave.

The following bill applies to both the New York State Teachers' Retirement System and the New York State and Local Employees' Retirement System:

Temporary Age 55/25 Retirement Option

Legislation Pending Introduction

Enacts a temporary retirement incentive program for certain public employees above age 55 and with 25 years of service.

Retroactive Membership - Socialize Cost

Legislation Pending Introduction

Amends Section 803 of the Retirement and Social Security Law to change the method of allocating the costs of obtaining a retroactive membership under such section by including the cost in the employer contribution rate rather than assigning a specific cost to each employer involved.

Reopen 803 with 2 Year Break in Service

Legislation Pending Introduction

Extends the provisions of Section 803 of the Retirement and Social Security Law to December 31, 2007. The provisions of Section 803 of the Retirement and Social Security Law gave public retirement systems the authority to grant retroactive membership to eligible retirement system members who could have joined a public retirement system, prior to when they actually did join, if properly notified.

Section 803 Buy Back – Interest

Waives the accrued interest charged to employees who buy back retirement service credit pursuant to the provisions of section 803 of the Retirement and Social Security Law.

Reduces from ten years to five years the number of years of service required by a member of the New York State Teachers' Retirement System, and the New York City Teachers' Retirement System and New York State Employees Retirement System to be eligible for a disability retirement allowance. In addition, the bill amends the disability retirement formula to conform to the federal Older Workers Benefit Protection Act.

35 Year Retirement

Vesting for Part-Time Teachers

Provides free health coverage for surviving spouses and partners when member dies because of a line of duty occurrence.

Inlcudes school nurses, staff nurses, head nurses, staff therapists, occupational therapists, physical therapists, supervisors of nurses and supervisor of therapists within the definition of "teacher" for all purposes, and inlcuding them in NYC TRS.

Provides that there is a nurse and/or therapist present at Committee on Special Education meetings, which concern health and safety issues.
